All about special educational needs

Approximately one in five children will have special educational needs (SEN) at some time during their school career. This means they may have difficulty with:

- Reading, writing, mathematics
- Understanding information and others, and expressing themselves
- Organising themselves
- Sensory perception or physical mobility
- Managing their behaviour
- Socialising with peers and/or adults

These difficulties cause barriers to the student's learning. The UTC Oxfordshire will assess students to identify their strengths, needs and the extra help they require.

They may be at one of two stages on the SEN Code of Practice SEN thresholds:

SEN Support: Extra help in-class from a learning assistant, small group support, ICT access and advice or support from outside agencies

Education, Health and Care Plan: when needs are complex and severe

What is offered to students at the UTC Oxfordshire:

The UTC offers the following according to students' special educational needs, in addition to Quality First Teaching:

- A curriculum to match needs
- Enhanced access to ICT or specialist equipment and aids
- In-class support from learning assistants
- Additional programmes in literacy and numeracy delivered in a small group or on a one-to-one basis
- One-to-one or small group work with a learning mentor
- Independent study support
- Student counselling
- Access to a 'key worker'
- Assessment and exam concessions
- Support from the Local Offer

Partnership with parents/guardians:

The school works in partnership with parents to meet the child's needs. This means:

- We listen to the views of parents

Information to parents/guardians:

- If an assessment or referral indicates that a student has additional learning needs the parents/carers and the student will always be consulted with regards to future provision.
- In cases where more frequent regular contact with parents/carers is necessary, this will be arranged based on the individual student's needs.

What to do if you have any concerns

- Speak to the teacher and SENCO
- Speak to the Principal of the UTC Oxfordshire
- Get advice from the local Parent Partnership Service

And if your concern is not resolved:

- Follow the school's complaints procedure
